Location:

- The Holiday Bazaar will be held on the 1st Sunday of December, from 12:00 PM 7:00 PM at The East Lake Co. Chamber Office, located at 24214 Sorrento Avenue, Sorrento, FL 32776. **THIS IS AN OUTDOOR EVENT!**
- All spaces are assigned on a first come, first served basis
- Spaces are approximately 11' x 11', capable of accommodating a 10' x 10' tent with tables/chairs
- Electricity will be available to a limited number of vendors on a first come, first served basis for an additional event fee of \$25.00

General Information:

- The event is scheduled & advertised from 12:00 PM to 7:00 PM.
- "Light Up Sorrento!" will be included within the Holiday Bazaar from 5:00 PM 7:00 PM, with "Photos with Santa" beginning approximately 6:15, directly following the Tree Lighting Ceremony.
- Vendor Spaces must remain set up throughout the "Light Up Sorrento!" event to perhaps boost your sales. However, no additional lighting will be provided.
- Vendors MUST remain set up throughout the event until at least 6:30 PM, unless you have sold out of your products
- This is a Family event, and there WILL be Children in attendance. We request you please keep your products "family friendly"!
- ELCC reserves the right to refuse the sale of any item we deem not agreeable to the general community and does not follow this minimal request. **NO REFUNDS will be given.**
- Vendors will provide a complete list of ALL items/products you will be selling with your submitted application.
- Vendors shall provide 3-5 photos of all craft items being sold.
- Vendor space is to be used for <u>ITEMS FOR SALE</u> by Crafters & Food Vendors, in addition to Business Vendors promoting their company, and we hope your sales & promotions will "Light Up" our event!
- The Chamber does not offer the opportunity to get or give change for your sales space.
- Vendors shall supply their own Tent, Tables & Chairs AND change.
- Set up must be completed by 11:30 AM. Designated parking after set up will be provided for Vendors.
- All sales tax is the Vendors' responsibility. The Chamber, its members & Board of Directors have, nor hold any liability for the sale or lack of sale, of any items.
- When finished for the day, Vendors are responsible for leaving their space as clean as when you arrived.
- Electricity will be supplied in specific limited areas and is on a first come, first served basis for an additional Vendor fee of \$25.00. EXTENSION CORDS WILL NOT BE SUPPLIED!
