# MRS. CLAUS'S HOLIDAY BAZAAR VENDOR RESPONSIBILITIES & REQUIREMENTS

### Location:

- The Holiday Bazaar will be held on the 1<sup>st</sup> Sunday of December, from 11:00 AM 5:00 PM at The East Lake Co. Chamber Office, located at 24214 Sorrento Avenue, Sorrento, FL 32776.
- All spaces are assigned on a first come, first served basis
- Spaces are approximately 11' x 11', capable of accommodating a 10' x 10' tent with tables/chairs
- Electricity will be available to a limited number of vendors on a first come, first served basis for an additional event fee of \$25.00

### **General Information:**

- The event is scheduled & advertised from 11:00 AM to 5:00 PM.
- "Light Up Sorrento!" will immediately follow the Holiday Bazaar from 5:00 PM 7:00 PM, with "Photos with Santa" beginning approximately 6:00, directly following the Tree Lighting Ceremony
- Vendor Spaces may remain set up throughout the "Light Up Sorrento!" event to perhaps boost your sales. However, no additional lighting will be provided.
- Vendors MUST remain set up throughout the event until at least 4:30 PM, unless you have sold out of your products
- This is a Family event, and there WILL be Children in attendance. We request you please keep your products "family friendly"!
- ELCC reserves the right to refuse the sale of any item we deem not agreeable to the general community and does not follow this minimal request. NO REFUNDS will be given.
- Vendors will provide a complete list of ALL items/products you will be selling with your submitted application.
- Vendors shall provide 3-5 photos of all craft items being sold.
- Vendor space is to be used for **ITEMS FOR SALE ONLY** and we hope your sales will "Light Up" our event!
- The Chamber does not offer the opportunity to get or give change for your sales space.
- Vendors shall supply their own Tent, Tables & Chairs AND change.
- Set up must be completed by 10:30 AM. Designated parking after set up will be provided for Vendors.
- All sales tax is the Vendors' responsibility. The Chamber, its members & Board of Directors have, nor hold any liability for the sale or lack of sale, of any items.
- When finished for the day, Vendors are responsible for leaving their space as clean as when you arrived.
- Electricity will be supplied in specific limited areas and is on a first come, first served basis for an additional Vendor fee of \$25.00. EXTENSION CORDS WILL NOT BE SUPPLIED!
